

Update XEU European Adoption Committee

Context

Situation

- ESMA to develop draft regulatory standards for adoption by the Commission, to specify the electronic reporting format, with due reference to current and future technological options, such as eXtensible Business Reporting Language (XBRL).
- Draft is due by 31 December 2016.
- After the submittal of the draft in 2016 and its subsequent approval, the local regulators will need to start implementing the rule locally.
- XBRL already is the incumbent technology in many financial regulatory data collection systems and has been such a success in a number of European countries.


What happened until today

- At the Dublin XII Conference (April 2013) a large EU meeting was held about the XBRL adoption in Europe to discuss the directives and the consultation to be launched by the EC with various short presentations from Piotr Madziar EC, Rob Kuipers SBR NL, Gilles Maguet XEU and Cees de Boer XII Board.
- The Executive Committee decided to launch the EU adoption Committee, chaired by Gilles Maguet and co-chaired by Dave van den Ende
- First call of EU Adoption Committee on June 6th to agree on goals and next steps

Goals of the EU Adoption Committee

- 1. Increase awareness at European institutions and MEPs of cross-border European XBRL network
- 2. Provide key stakeholders with high quality and consistent information about XBRL adoption across Europe
- 3. Support jurisdictions and European member states (including EU Candidate and Pre-Accession Countries) in conversations with local stakeholders
- 4. Support European institutions with answering XBRL related questions.
